# **Additional PTIP Information and Estimated Cost Examples**

# **Felony Offenses**

## **COUNSELING CLASSES**

Counseling Classes are required for all PTI Programs, and must begin within the first month.

## **COST OF COUNSELING**

A list of offenses and estimated costs of counseling are as follows:

### Costs for **Theft Related** Offenses

A \$45.00 fee for your initial consultation. There are five subsequent required classes. The cost is \$70.00 per class. Each class lasts approximately 2 hours. The total cost for your consultation and all 5 classes is \$395.00. Additional classes may be recommended, which you may be required to take.

### Costs for **Drug/Alcohol** Related Offenses

A \$45.00 fee for your initial consultation. There are six subsequent required classes. The cost is \$70.00 per class. Each class lasts approximately 2 hours. The total cost for your consultation and all 6 classes is \$465.00. Additional classes may be recommended, which you may be required to take.

### Costs For Domestic Violence and Anger Management Classes

\$75.00 for your initial consultation and \$45.00 per class. A total of 12 Classes are required for Anger Management Total Cost \$615.00

\$75.00 for initial consultation and \$45.00 per class. A total of 18 classes are required for Domestic Violence. Total Cost \$885.00

Additional classes may be recommended, which you may be required to take.

#### CHILD SEX ABUSE COUNSELING

Counseling classes are provided by a Certified Licensed Counselor. The cost and classes required are determined by the Counselor.

#### NON-SEXUAL CHILD ABUSE

You must enroll in a "DHR Approved" Parenting Class, and complete 100 hrs of community service. You must provide proof of both to your PTIP Coordinator upon completion.

#### REPORTING INFORMATION

Monthly reporting dates are the first Monday or Tuesday that follows, each month between the hours of 8:30 AM and 3:30 PM.

Accepted forms of payment are cash, money order, or a certified check from your bank.

# ESTIMATED PTI PROGRAM COSTS

## 24 month Program –NOT Indicted

Felony application fee: \$200.00 Administration fee: \$240 (\$10/month)

## 24 month Program – Indicted

Felony application fee: \$300.00 Administration fee: \$240 (\$10/month)

#### Estimated **monthly** payments:

If your attorney was retained, your estimated monthly payment is \$120.00 (includes administrative fee, court costs, drug test fee, and Administration fee)

If you have a court appointed attorney, your estimated monthly payment is \$170.00

Your payment would increase if your court appointed attorney fees are over the estimated amount of 1000.00; or if you have more than one charge, and/or owe restitution.

# **Misdemeanor Offenses**

If you **charged** with a misdemeanor, the estimated costs are as follows:

\$200.00 Administration Fee \$240.00 Supervision Fee

## Estimated monthly payments:

If your attorney was retained, your estimated monthly payment is \$100.00 If you have a court appointed attorney, your estimated monthly payment is \$110.00 Your payment would increase if your court appointed attorney fees are over the estimated amount of 1000.00; or if you have more than one charge, and/or owe restitution.
